Expressions of Interest

The Gas Regulatory Authority (hereinafter called "Client") has received funds from the European Union (EU) delegated to the Agence Française de Développement "AFD" (hereinafter referred to as the "Agency") towards the Implementation of a Targeted Financial Support to Disadvantaged Households for the Payment of Natural Gas connection fees and an institutional capacity building program for the Gas Regulator (hereinafter referred to as the "Project"). Since the regulation experience is new to the Egyptian market in oil & gas sector, a part of the funds was dedicated to the capacity building and training programs of GasReg employees due to the important and new role that this independent regulator plays in Egypt in order to encourage new investments and competition.

A Training need assessment was conducted by an independent consultant for all GasReg staff and it resulted in a capacity building a training plan for a budget estimated up to a maximum of 500,000 euros.

The Services provided by the Training Implementer shall consist of "Reviewing, updating and implementing the capacity building and training plan in coordination with the Client and according to the work priorities needs against administration fees"; the scope of Services shall include, but not be limited to, the following:

- Communication and arrangement with the capacity building providers (ex: institutions, events organizers, peer regulators, schools and faculties, Events and conferences organizers etc.);
- Defining potential countries for the study tours and managing the communication with partners in visited countries to agree on the agenda for study visits and negotiating hosting fees with partners obtaining the best offers:
- Procuring all logistics required for capacity building and training plan implementation and all travel arrangements such as: program registration and enrollment, visa, flight tickets, accommodation, travel required docs (such as insurance, medical insurance, PCR, vaccination certificates, etc), transportation means and transportation from and to the airport in home and host country, etc.);
- Preparing the implementation upcoming plan monthly and when requested by the Client;
- Reporting the implemented activities monthly and when requested by the Client;
- Managing with flexibility any participant substitutions or any change in the travel plan due to work priorities and needs or as may be required;
- Providing any other services required for the implemnentation of the capacity building and training program;
- Assigning a dedicated skillfull and experienced team from the Training implementer personnel to execute and monitor the implementation of the Services.

The Applicant shall submit only one application, either in its own name or as a member of a Joint Venture (JV). If an Applicant (including any JV member) submits or participates in more than one application, those applications shall be all rejected. However, the same Sub-consultant may participate in several applications.

If the Applicant is a JV, the expression of interest shall include:

a copy of the JV Agreement entered into by all members,

or

 a letter of intent to execute a JV Agreement, signed by all members together with a copy of the Agreement proposal,

In the absence of this document, the other members will be considered as Subconsultants.

Experiences and qualifications of Subconsultants are not taken into account in the evaluation of the applications.

Interested Applicants must provide information evidencing that they are qualified and experienced to perform those Services. For that purpose, documented evidence of recent and similar services shall be submitted.

Determination of the similarity of the experiences will be based on:

- The Nature of Services.
- Previous Experience in the same field by contract
- Previous contracts size and duration.
- The technical area and expertise.
- The location of the Applicant.
- The Certificates, Alliances, Awards acquired by the Applicant.
- Language: all the documents shall be in English (some communication or documents may be requested by the Client in Arabic language).

Among the submitted applications, *GasReg* will shortlist a maximum of six (6) Applicants, to whom the Request for Proposals to carry out the Services shall be sent.

Statement of Integrity, Eligibility and Environmental and Social Responsibility

 - 3.2 Having a business or family relationship with a Contracting Authority's staff involved in the procurement process or the supervision of the resulting Contract, unless the stemming conflict of interest has been brought to the attention of AFD and resolved to its satisfaction;
 - 3.3 Being controlled by or controlling another bidder or consultant, or being under common control with another bidder or consultant, or receiving from or granting subsidies directly or indirectly to another bidder or consultant, having the same legal representative as another bidder or consultant, maintaining direct or indirect contacts with another bidder or consultant which allows us to have or give access to information contained in the respective applications, bids or proposals, influencing them or influencing decisions of the Contracting Authority;
 - 3.4 Being engaged in a consulting services activity, which, by its nature, may be in conflict with the assignments that we would carry out for the Contracting Authority;
 - 3.5 In the case of procurement of goods, works or plants:
 - Having prepared or having been associated with a consultant who prepared specifications, drawings, calculations and other documentation to be used in the procurement process of this Contract;

- 6.4 We have not promised, offered or given and we will not promise, offer or give, directly or indirectly to any Person who occupies an executive position in a private sector entity or works for such an entity, regardless of the nature of his/her capacity, any undue advantage of any kind, for himself or another Person or entity for such Person to perform or refrain from performing any act in breach of its legal, contractual or professional obligations;
- 6.5 We have not and we will not engage in any practice likely to influence the contract award process to the detriment of the Contracting Authority and, in particular, in any anti-competitive practice having for object or for effect to prevent, restrict or distort competition, namely by limiting access to the market or the free exercise of competition by other undertakings;
- 6.6 Neither we nor any of the members of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants shall acquire or supply any equipment nor operate in any sectors under an embargo of the United Nations, the European Union or France:
- 6.7 We commit ourselves to comply with and ensure that all of our suppliers, contractors, subcontractors, consultants or subconsultants comply with international environmental and labour standards, consistent with laws and regulations applicable in the country of implementation of the Contract, including the fundamental conventions of the International Labour Organisation (ILO) and international environmental treaties. Moreover, we shall implement environmental and social risks mitigation measures when specified in the environmental and social commitment plan (ESCP) provided by the Contracting Authority.

We, as well as members of our joint venture and our suppliers, contractors, subcontractors, consultants or subconsultants authorise AFD to inspect accounts, records and other documents relating to the procurement process and performance of the contract and to have them audited by auditors appointed by AFD.
